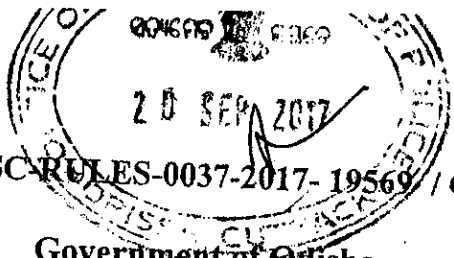

NOTIFICATION

Bhubaneswar, dated the 12<sup>th</sup> September, 2017.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Group- B Posts (Contractual Appointment) Rules, 2013; namely-

1. (1) These rules may be called the Odisha Group-B Posts (Contractual Appointment) Amendment Rules, 2017.
- (2) They shall be deemed to have come into force with effect from the 1<sup>st</sup> day of January 2016.

2. In the Odisha Group-B Posts (Contractual Appointment) Rules, 2013 (here in after referred to as the said Rules) for rule 10 the following rule shall be substituted, namely:-

“10. Remuneration: During the period of contractual appointment they shall draw monthly remuneration at the rates prescribed in the Annexure appended to these rules as applicable to their number of completed years of service.”

3. In the said Rule, for rule 11 the following rule shall be substituted, namely:-

**“11. Annual Increase of Remuneration:** Subject to satisfactory performance, the remuneration of contractual employees shall be enhanced as per slabs prescribed under Annexure appended to these rules on completion of each year of service.”

4. In the said Rules, the following Annexure shall be appended, namely;


