A7 October, 2021 In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Group-B posts (Contractual Appointment) Rules, 2013; namelyc-

1. Short bible and Commencement -- (1) These rules may be called the Odisha Group B posts (Contractual Appointment) Amendment Rules, 2021.

(2) They shall come into force on the date of their publication in the Oolisha Gazette.

2. In the Odisha Group-8 posts (Contractual Appointment) Rules, 2013 (here-inafter referred to as the said rules), in rule 2, in sub-rule (1), after clause (b), the following clause shall be inserted, namely:-

"(b-1) "Initial Appointees" means the persons appointed to any Group-B points by way of direct recruitment made under rule 5;*

3. In the said rules, for rule 9, the following rule shall be substituted, namelys-

"9. Tenure of Initial Appointees .- Persons appointed under sub-rule (2) of 2.11 rule 5, shall continue as Initial Appointees for a period of six years, which shall be reckoned from the date of their appointment under rule 5."

4. In the said rules, for rule 10, the following rule shall be substituted, namely:---*10. Remuneration --- During the period of initial appointment, the initial of appointees shall draw monthly remuneration at the rates prescribed in the Annexure apponded to these rules as applicable to their number of completed years of service."

5. In the said rules, for rule 11, the following rule shall be substituted, namely:--

"11. Annual Increase of Remuneration.— Subject to satisfactory performance, the remuneration of initial appointees shall be enhanced as per slabs prescribed under the Annexure appended to these rules on completion of each year of service."

6. In the said rules, for rule 12, the following rule shall be substituted, namely:---

"12. Allowances: The initial appointees shall not be entitled to D.A., HRA, and other allowances except RCM during the period of initial appointment."

7. In the said rules, for the Annexure, the following Annexure shall be substituted with, namely:---
