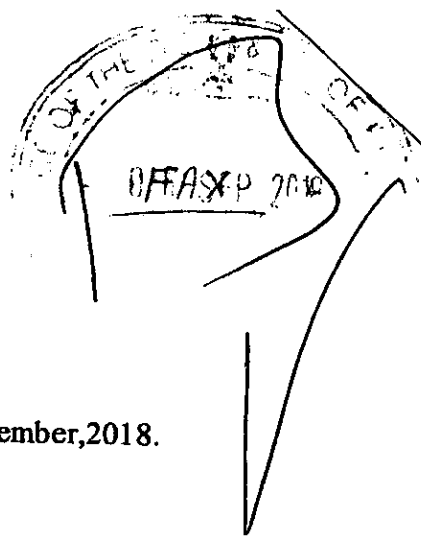


Sub: - Permission for leave/LTC/Training etc. during Assembly Session-Reg.
