Sub: Enhancement of Uniform/Dress Allowance in favour of OPS and OAPS officers in Odisha Police

The proposal for enhancement of Dress Allowance to OPS and OAPS officers in Odisha Police was under consideration of State Government for some time past. After careful consideration, the state Government have been pleased to enhance the Uniform/Dress Allowance @Rs.6,000/- per annum in favour of OPS and OAPS officers in Odisha Police in lieu of existing uniform grant and kit maintenance allowance, etc subject to following stipulations:

1. The present allowances shall be sanctioned every year in the month of July.
2. The officers already in receipt of the existing grant for the period July onwards shall be deducted from the present grants for the first year.
3. The Officers who have less than 06 month of service for superannuation on the 1st date of July shall not be allowed uniform allowances for that year.
4. The SPHQ shall prescribe the dress code for all the officers to maintain uniformity.
5. The Officers shall furnish undertaking at the time of sanction of allowances for utilization of funds for the purpose for which it is sanctioned.

This has been concurred by the Finance Department in OSWAS file No.HOME-SPS-RULE-0001-2020.


