It has come to the notice of the Government that the procedures regarding the reimbursement of cost of treatment (i.e. surgical intervention diagnostic test, accommodation charges etc.) in case of hospitals inside /outside the State for the State Government employees and their family members have been governed by the Resolution No-6246, dated-04-03-2014 of Health and Family Welfare Department and it has not been revised since its notification

Similarly, the Office Memorandum No-4-18/2005-C&P (Vol-1-PI (I), dated 20 02 2009 of the Ministry of Health and Family Welfare, (OGHS (P) Division). Government of India has not also been revised, which has been issued retaining to the reimbursement cost of treatment in case of hospitals Inside routside the State for the Central Government employees and their family members.

But there are no Notifications / Memorandums/ guidelines on eligibility of the reimbursement of Medical claim for the persons belonging to constitutional posts. High Court Judges all India Service Cadre like IAS / IPS / IFS working in State Cadre and they are submitting their bills for reimbursement cost of treatment in case of hospitals inside /outside the State.

In order to resolve the issue of the claims of the reimbursement cost of treatment in case of hospitals inside fourside the State for all the State Government Employees & their families. Central Government employees working in the State cadre and their families and the persons belonging to constitutional posts. High Court Judges and their families. Use State Government have been pleased to form a Technical Standing Committee with the following members.

The Committee will co-opt for subject matter specialists and will examine the claims in detail taking the circumstances for seeking treatment on case to case basis on its merit and their eligibility and recommend the same for approval of the Government
