Sub: Extension of time limit for filing of TDS return in FORM GSTR-7 for the month of October, 2018 to July, 2019 by 31st August, 2019.

The section 51 of the Odisha Goods and Services Tax Act, 2017 came into force from 1st October, 2018 which provides for deduction of tax @2% (i.e. 1% OGST+ 1% CGST in case of Intra-State Supply or 2% IGST) by the Government Departments/Agencies/Local Authorities or any other person notified in this respect, from the payment made to the supplier of taxable goods or services or both, where the total value of such supply, under a contract, exceeds two lakh and fifty thousand rupees. The amount deducted as tax under this section is paid to the Government by deductor (DDO) within ten days after the end of the month in which such deduction is made along with a return in FORM GSTR-7 giving the details of deductions and deductees. In this respect, it is intimated that Government vide Notification No.26/2019 — Central Tax dated 28.06.2019 have extended the time limit for furnishing the return by a registered person required to deduct tax at source under the provisions of section 51 of the said Act in FORM GSTR-7 for the months of October, 2018 to July, 2019 till the 31st day of August, 2019.

In addition to the guidelines issued by this Department vide Memo No. 30797/F dated 25.09.2018 regarding deduction and deposits of TDS by the DDOs under GST, the procedure to verify the validity of GSTIN of the Suppliers by the DDOs is attached as Annexure-A. The GSTIN(GST Identification Number) of a registered tax payer can be verified by the DDOs through the GST Common portal-.— www.gst.gov.in. No login or User ID is required for the same.

All sub-ordinate offices under your control may be instructed to file return in FORM GSTR-7 in time to avoid payment of interest and late fee under OGST/CGST Act.



PROCESS TO VERIFY THE STATUS OF GST REGISTRATION NUMBER (GSTIN)


Step 1- Please go to the GST Common portal – www.gst.gov.in. The page will open as can be seen from the screenshot below.



Step 2- Select the Tab - "Search Taxpayer", as marked above. The following link will open.




Step 3- Click on the link "Search by GSTIN/UIN", the following page will open.






Step4- In the above page, please enter the GSTIN. After entering the GSTIN, the System will ask to enter a captcha (a set of random characters) as can be seen from the screenshot below.



<u>Step 5</u>-Once the GSTIN and captcha are entered, click on the "Search" button and the GST Portal will display the details of the tax payer as can be seen from the screenshot below.



Step 6-If the "GSTIN/ UIN Status" shows "Active", it implies that the registration of the searched taxpayer is active and valid on that date of search. If the "GSTIN / UIN Status" is shown as "Inactive" or "Cancelled" or "Provisional" etc. it implies that the registration of the searched taxpayer is not valid on that date of search.
