



OFFICE ORDER

Bhubaneswar dated the 8th October, 2021.

No.GAD-SER1-IAS-0017-2015- 27278/AIS.I., The Government of India, Ministry of Finance, Department of Expenditure in their Office Memorandum No.1/1/2020-E-II (B), dated 20.07.2021 have enhanced Dearness Allowance payable to the Central Government Employees from existing rate of 17% to 28% on the Basic Pay, with effect from 01.07.2021. The increase subsumes the additional installments arising on 01.01.2020, 01.07.2020 and 01.01.2021 which were frozen vide Government of India, Ministry of Finance, Department of Expenditure Office Memorandum No. 1/1/2020-E-II (B), dated 23.04.2020. The State Government in Finance Department vide their Office Memorandum No. 28337/F., dated 08.10.2021 have released this does of D.A. in favour of the State Government Employees w.e.f. 01.07.2021.

The State Government have decided that the Additional dose of D.A. @11% of Basic Pay w.e.f. 01.07.2021 shall be released in favour of the Members of All India Services working in connection with the affairs of the State Government as the following manner.

3. Date from which payable

Rate of DA

01.07.2021

@ 28% of Basic Pay

4. D.A. in accordance with this Memorandum will also be admissible to the AIS Officers who were in service on 01.07.2021, but have ceased to be in service at the time of sanction of D.A. as per the revised scale of pay.

5. The Additional dose of DA will be paid in cash and can be drawn in the Pay Bill of **October, 2021** payable in the month of **November, 2021** and onwards. Arrear from the month of **July, 2021 to September, 2021** on account of the enhanced D.A. shall not be drawn before the date of disbursement of salary of **October, 2021**.


6. The bill for drawal of D.A. as per revised scale of pay will be submitted to all Treasuries / Special Treasuries / Sub-Treasuries along with the pay bill for the month of **October, 2021** and onwards.

7. The term of "Basic Pay" in the revised pay structure means the pay drawn in the prescribed level in the Pay Matrix but does not include any other type of pay like Special Pay.

8. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions, of less than 50 paise may be ignored.

9. The payment of arrear of Dearness Allowance from the month of **July, 2021 to September, 2021** on account of enhanced D.A. will be drawn and disbursed latest by **31.03.2022**.


