No. HOME-DA1-MISC-0140-2013/ 18533 / D&A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of previous notification relating to territorial jurisdiction of Brahmagiri Police Station, the State Government do hereby declare establishment of a Marine Police Station at Arakhakuda in Sadar Sub-Division of Puri District to be called as Arakhakuda Marine Police Station under Coastal Security Scheme, Phase - II approved by the Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between Bahiharachandi under Brahmagiri Police Station and Paikarapur under Krushnaprasad Police Station with the territorial land comprising hamlets and revenue villages as mentioned in the Schedule below and direct that the villages/hamlets which were hitherto included in Brahmagiri Police Station shall cease to have so included in the said Police Station on the date of publication of this notification in the Odisha Gazette.
