No.HOME-DAT-MISC-0064-2014/ 18579 / D. & A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of this Department notification No.10553/D&A dated 25.02.2009 and notification relating to Chandipur Police Station, the State Government do hereby declare transfer of six villages specified in column (2) of the schedule below from the jurisdiction of Chandipur Police Station to the jurisdiction of Balaramgadi Marine Police Station in Balasore district established under Coastal Security Scheme of Ministry of Home Affairs, Government of India. The said Marine Police Station shall have jurisdiction over territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between 87° 01'E, 21° 28'N at Parikhi and 86° 51'E, 21° 08'N at Kansabansa river under Soro Police Station and direct that the villages/hamlets which were hitherto included in Chandipur Police Station shall cease to have so included in Chandipur Police Station on the date of publication of this notification in the Odisha Gazette.
