NOTIFICATION

Nó.HOME-DA1-MISC-0071-2014/ 30010 / D&A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of this Department Notification No.10571/D&A dated 25.02.2009 and notification relating to jurisdiction of Balikuda Police Station, the State Government do hereby declare establishment of a Marine Police Station at Bandar in Jagatsinghpur District to be called as **Bandar Marine Police Station** under Coastal Security Scheme, Phase - II of Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between Marichipur village of Marichipur Gram Panchayt and Bairekha village of Naharana Gram Panchayat under Balikuda Police Station with the territorial land comprising hamlets and revenue villages as mentioned in the Schedule below and direct that the villages/hamlets which were hitherto included in Balikuda Police Station shall cease to have so included in the said Police Station on the date of publication of this notification in the Odisha Gazette.
