No.HOME-DA1-MISC-0071-2014/ 30017 / D&A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of this Department Notification No.10591/D&A dated 25.02.2009 and notification relating to jurisdiction of Paradeep Police Station, the State Government do hereby declare establishment of a Marine Police Station at Sandhakuda in Jagatsinghpur District to be called as **Jatadhari Muhan Marine Police Station** under Coastal Security Scheme, Phase - II of Ministry of Home Affairs, Government of India, which shall have jurisdiction over the territorial waters in Bay of Bengal extending up to 12 Nautical Miles from the coast line between border point of village Marichipur of Marichipur Gram Panchayt under Balikuda Police Station and Sandhakuda village in Paradeep Municipality area under Paradeep Police Station with the territorial land comprising hamlets and revenue villages as mentioned in the Schedule below and direct that the villages/hamlets which were hitherto included in Paradeep Police Station shall cease to have so included in the said Police Station on the date of publication of this notification in the Odisha Gazette.
