1. Applicants for jobs at serial 1 to 4 must be:
 - a. Retired from Government service
 - b. Below the age of 65 years
 - c. Having good service record
 - d. Physically fit
2. Last date for receipt of Application is 31.05.2023.
3. The shortlisted candidates shall be called for an interview at Cuttack.
4. Only the candidates selected for interview shall be informed by E-mail/Phone.
5. The candidate selected for interview shall make their own arrangements and bear the cost to attend the interview at Cuttack.
6. Officers against whom departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.
7. The retired personnel shall be engaged in terms of GA & PG Department Notification No. 23750 dated 27.08.2014 and their remuneration is to be fixed as per FDOM No. 24533/F dtd. 29.09.2022 for the purpose.

Job Description Investigation Support Unit Team Member

1. **Retired Additional SP / Retired Deputy SP** – He/she shall be responsible for monitoring the investigation of group of important cases allocated by the head of ISU. He/she shall discuss each case and its progress with the head of ISU/SP of the corresponding district. He/she shall guide the respective IOs/SOs of the cases and suggest corrective action to be taken regarding the investigation. He/she shall monitor the compliance of the instructions passed on the cases.
2. **Retired Scientific Officer** – He/she shall be responsible for giving opinion on the evidence collected already or give directions to the concerned IO on how to collect the evidence of occurred crime. He/she shall also discuss the evidence and its report with the concerned counterpart from the SFSL team.
3. **Retired Public Prosecutor / Retired Judicial Officer** – He/she shall be responsible for giving advice to the concerned IO on the legal ramifications and the IPC/SLL sections applicable to the concerned case. If the concerned case is already in prosecution stage, he/she shall coordinate with the concerned government prosecutor regarding the proceedings of the case and suggest any changes if required.
4. **Retired Forensic Doctor** - He/she shall be responsible for giving opinion on the evidence collected already or give advice to the concerned IO on how to collect the evidence in case of a recently occurred crime. He/she shall also discuss the evidence and its report with the concerned counterpart from the Health Department and the SFSL team.
5. **Banker / Retired Chartered Accountant** – The selected candidate shall be requested to report to the ISU as and when required. He/she shall be required to give opinion during investigation of financial fraud / cyber fraud cases. He/she shall suggest heading of ISU on the type of financial information which will be required to successfully detect the case or prosecute the accused.

Other Terms and Conditions: -

1. The above-mentioned officers/personnel shall report to ADGP/IGP, CID-CB/Head of the ISU.
2. The Investigating Officers (IOs) can reach out to the above-mentioned officers/personnel for any advice/help/assistance for any case through call/video call or meeting in person.
