Sub:- Implementation of Motor Vehicles (Amendment) Act, 2019.

Sir,

The Motor Vehicle Act has been amended and the enhanced penalties for various offences, is effective from **01.09.2019**, as per Notification No. SO-3110 (E) dated 28.08.2019 of Ministry of Road Transport & Highways.

You are requested to ensure collection of enhanced fines for offences as per amended Act. A table containing the enhanced fines as per the new amendment vis-à-vis old one is enclosed.

It is already instructed to shift the present mode of manual enforcement to e-challan in case of Police officials. Transport Department will provide 500 machines in the first instance and integrate with VAHAN & SARATHI application. This may be implemented early.


In case of drunken driving, instructions are already issued vide Home Department letter No.1986 dated 13.08.2019 to invoke inherent powers with Police conferred under section-202 and 203 of M.V. Act to arrest people indulging in drunken driving. This may be carried out immediately.

Also for Highway patrolling in selected 5 stretches, Rs.10 crore has been provided out of State Road Safety Fund. This need to be made functional.

All the above steps will improve Road Safety in the State. Therefore, you are requested kindly to take necessary steps by issuing suitable instructions to all S.Ps. /Commissioner of Police.

This may be treated as most urgent.
