GUIDE-LINES FOR SUBMISSION OF RECOMMENDATIONS FOR THE AWARD OF PRESIDENT'S POLICE MEDAL FOR DISTINGUISHED SERVICE, / POLICE MEDAL FOR MERITORIOUS SERVICE MEDAL FOR ME

According to President's Secretariat Notification No.3-Press and No.4-Pres, dated: 1.3.1951, as amended from time to time, the recommendations for the award of President's Police Medal for Distinguished Service and Police Medal for Meritorious Service on the occasion of Independence Day, 2013 are required to be sent by the Home Department of the State to the Ministry of Home Affairs latest by 15.5.2013.

- 2. Particulars of each officer /men nominated for either of the award may be furnished in the prescribed formats. Viz. Annexure-I, Annexure II, Annexure-III and Annexure-IV (copies of which are attached) correctly and clearly.
- 3. Three (3) complete sets of recommendations i.e. annexure I, Annexure II, Annexure IV and other documents in respect of each recommendee duly signed by the Nominating / Recommending Authority may be sent to this Headquarters for the purpose.
- 4. Description of work justifying award of Medal (to be mentioned against Col.19 of the Annexure-I and at the bottom of Annexure-II) should be brief and limited to 200 words and should highlight the achievements and good work done by the recommendee in order of importance without any posting details.
- 5. Police personnel with "Outstanding" / "Very Good" and "Good" record of service should only be recommended and those having a poor record or adverse remarks in their A.C.Rs. / C.C.Rs during the year 2002 to 2013 should not be recommended. It may also be ensured that the recommendee should not have earned any Average ACR / CCR during the period under review i.e. 2002 to 2013. In this regard, the Annual Confidential Rolls / C.C.Rs of the concerned recommendee should be verified very carefully before making recommendations.

- 6. Over all P.A.Rs. /C.C.Rs. assessment viz. "Outstanding" / "Very Good" / "Good" etc. for each year may please be mentioned clearly year wise against Col.17 of the Annexure -I and 19 of Annexure -I.
- 7. "Integrity / Character and Antecedent Certificate" in Annexure III and record verification certificate in Annexure -IV in respect of each recommendee duly filled in may be attached with each copy of the recommendation.
- 8. Brief details of Major /Minor punishments (year wise) awarded to the recommendee during the year 2002 to 2013, if any, should also be attached with the recommendation with detail D.O. reference.
- 9. In the case of officers on "deputation" a "No Objection Certificate" from the borrowing cadre / office or lending cadre / office (as the case may be) should invariably be sent along with the recommendations. The recommendations in respect of "deputationists" if received without a "No Objection Certificate" from the parent / lending cadre /office (as the case may be) are liable to be rejected summararily. In the case of State Police Officers working on deputation in the Ministries of the Government of India, public sector undertakings etc. the recommendations may be sent in accordance with Ministry of Home Affairs letter No.VI-11011/7/78-GPA-III, dtd. 27th November, 1978.
- 10. No recommendation should be made for the award of president's Police Medal for Distinguished Service unless—the Police personnel (Other than I.P.S.) has completed 25 years of Police service and a period of 6 years has elapsed since the award of Police medal for meritorious service. Similarly, no recommendation should be made for the award of Police medal for Meritorious Service unless the Police personnel (other than I.P.S.) has completed 20 years of Police Service.
