RESOLUTION

No. 31919/PW, Bhubaneswar,

Sub: Award of DGP's Discs to Police personnel on the occasion of
Odisha Police Formation Day every year.

The Police personnel of various ranks, who have rendered spectacular meritorious service, may be awarded the DGP's Discs not exceeding 50 in number in a year.

2. These discs may be awarded by the Director General of Police on the Police Formation Day, on 1st of April every year for the preceding period of one year beginning from 2011-12.

3. The DGP's discs shall be awarded irrespective of the cash or other awards / rewards given to a person in the same year.

4. The decision to award the DGP's discs will be taken by the Director General of Police over the period of one year, as and when the spectacular meritorious service rendered by any Police personnel comes to his notice. Details of the spectacular meritorious service shall be reduced in writing and shall be certified by a Police Officer, who has the direct knowledge of the rendering of such service. Such certificate shall also be countersigned by a superior Police Officer.

5. If, however, anything adverse comes to the notice of the Director General of the Police against the person decided to be awarded the DGP's discs, during the remaining period of the year, the Director General of Police may cancel the decision of the award of the discs and in his place, another deserving person may be selected.

6. The DGP's discs to be awarded shall be made of German Silver and will conform to the sample recommended by the State Police Headquarters in their Letter No. 30899 dtd. 26.06.96.

7. The Resolution No. IPW-22/05-15997 dtd. 30.03.2005 on the award of DGP's discs to Police personnel is hereby repealed.
