Sub: Awards to Police Personnel.

The question of giving awards to Police personnel in recognition of meritorious service rendered by them was under consideration of Government. After careful consideration, the Governor has been pleased to institute a system of Cash Awards to the Police personnel as indicated below:-

There shall be two levels at which awards would be admissible, District 2. Level and State Level. The amounts admissible to each Awardee are indicated below:

3. Eligibility for consideration:-

4. Criteria for selection:

Selection may be made taking into consideration the following criteria, apart from outstanding work done in any other field.

(a) Constable, Head Constables, Havildars.

- i) Smartness and turn-out.
- ii) Sense of discipline.
- iii) Dealings with public.
- iv) Integrity.

(b) Sub- Inspector s and Inspectors:-

- i) Smartness and turn-out
- ii) Sense of discipline.
- iii) Dealings with public.
- iv) Integrity.
- v) Detective ability
- vi) Exercise of control and supervision over sub-ordinate
- vii) Intelligence collection.
- viii) Remark in the C.C.Rolls.

(c) For selection of best OSAP Battalion:-

- i) Discipline.
- ii) Drills in vogue.
- iii) Field draft exercises.
- v) Weapon training & sports and games.
- vi) Shooting.
- vii) Riot, Drill and Crowd Control
- viii) Office management.

5. Selection Committee:-

Selection for District Level Awards would be made for each District by a Committee consisting of the following:-

Î.	Range Deputy Inspector General of Police -	Chairman.
n	District Superintendent of Police.	Member.
iii.	Any other officer not below the rank of addl S.P. to be nominated by the Director General & Inspector General of Police.	Member.

For all other awards, the D.G. & I.G. of Police may constitute one or more Selection Committee with a Spl. I.G of Police as Chairman and 2 D.Is.G of Police as members.

6. The decisions of the Selection Committee shall be binding.

- 7. All the selections, both for District Level Awards and State Level Awards for a Calendar year shall be completed, as far as possible, by the end of the month of February, if the following year and the awards shall ordinarily be made on the 1st. day of April every year.
- 8. Where a person selected for an award is subsequently suspended or is proceeded against for any misconduct before getting the award, he would automatically be debarred from receipt of such award.
- 9. The Director General and Inspector General of Police who will be in over all charge of implementation of the scheme of awards may issue supplementary instructions as and when required, to facilitate smooth and orderly implementation of the scheme.

10. Any doubt in respect of interpretation of any provision contained in this Resolution may be referred to Home Department for clarification.

ORDER: Ordered that this resolution be published in the next issue of the Odisha Gazette and copy forwarded to all Deptts. of Govt./DG & IGP and all other Heads of Deptts./AG, Odisha, Bhubaneswar/ D.A.G., Odisha, Puri for information and necessary action.

Awards to Police Personnel.

In this Department Resolution No. 58752/P, Dt.17.08.87, Cash rewards to various ranks of Police Personnel have been prescribed for their meritorious service to be awarded every year both at District Level and at State Level. In the said Resolution, however, the rank of A.S.I. has been omitted. Since the ASIs, play an equally important role in investigation of cases at Police Station Level, the question of prescribing cash rewards for them was under consideration of Govt. After careful consideration, it has been decided that Cash Rewards will also be awarded to the best A.S.I. at District Level at the rate of 750/- per year and to the best A.S.I. at State Level at the rate of Rs. 1500/- per year. The eligibility criteria and mode of selection prescribed in the earlier resolution with mutandis –mutandis apply for selection of best A.S.Is.

In accordance with the Govt. of Odisha, Home Department Resolution No. 58752/ P dtd. 17. 08. 87, read with Para-2 (a) v) and (b) v) and vi), there is provision for Cash Award to the Best O.I.C of Police Station at District and State Level and Best Circle Inspector of Police at State Level.

During last few years, the post of Officer-In-Charge held by officers in the rank of Sub-Inspector of Police of many Police Stations in the Districts have been upgraded to that of Inspector-In-Charge and all posts of Circle Inspector of Police have been upgraded to S.D.P.O for which at present the post of Circle Inspector of Police is non-existent in the state.

In exercise of power conferred at para-9 of the aforesaid Resolution, the following supplementary instructions are issued with respect to Para-2 (a) (v), (b) (v) & (vi) and Para-3 of the said Resolution for orderly implementation of the said scheme in view of the recent changes as enumerated above.

(d) Inspector- In-Charge of Police Station- 1 Year. The criteria and mode of selection and other instructions laid down in the aforesaid Resolution of the Govt. remain unchanged.
