

CORRIGENDUM TO THE REQUEST FOR PROPOSAL (RFP) FOR SELECTION OF SYSTEM IMPLEMENTATION PARTNER (SIP) FOR CONDUCT OF COMBINED POLICE SERVICE EXAMINATION (CPSE-2018 & 2019) OF GROUP-B POSTS OF ODISHA POLICE SERVICE, ODISHA PRISON SERVICE AND ODISHA FIRE SERVICE.

In continuation to the Revised "Request for Proposals" (RFP) Ref:-e-RFP No. SPHO/Cuttack/HO/7/21-22/ET/7, Dtd. 24.12.2021 [Recruitment of Sub Inspector] published on MSTC on dtd.24.12.2021 for Selection of System Implementation Partner (SIP) for conduct of Combined Police Service Examination (CPSE-2018 & 2019) of Group-B Posts of Odisha Police Service, Odisha Prison Service and Odisha Fire Service, State Police Headquarters herewith issues corrigendum/ modification notice today i.e. 13.01.2022 effecting certain amendments/ clarifications/ modification in some clauses of the RFP which is available on the MSTC platform. On receipt of Pre-bid Queries from different bidders, the bidders are advised to take into account the said amendments / clarifications/modifications before submission of their bids against the RFP.

The last date & time of receipt of proposal is dtd.07.02.2022 at 17.00 hrs. If any bidder have already submitted his/her bid, he/she should re-submit his/her bid taking into account the amendments/ clarifications/ modifications notified in this Corrigendum Notice issued today i.e on 13.01.2022. The following modifications as enclosed herewith are made after considering all the Pre-bid queries. Wherever no alteration has been made it implies that the query raised has not been accepted.


