**Sub:-** Creation of posts for District Police Offices  
Sir,

I am directed to convey the sanction of the Governor for creation of 4(four) posts of Junior Clerk in the SOG Wing and 3(three) posts of Junior Clerk in the S.S. Battalion under Commissionerate of Police in the scale of pay of Rs.5200-20200 + Grade Pay Rs.1900/- with usual D.A. and other allowances as admissible from time to time with effect from the date the posts are actually filled up


Simultaneously 4(four) posts of Junior Grade Typist in SOG Wing and 3(three) posts of Junior Clerk-cum-Typist in the S.S. Battalion under Commissionerate of Police shall be abolished in lieu of equal number of posts of Junior Clerk created.

Having "Basic Computer knowledge" shall be made a mandatory eligibility criteria for the posts of Junior Clerk and the recruitment shall be made in a transparent manner following the relevant recruitment rules and provision of ORV Act.

The charge is debitable under "Demand No.1-2055-Police - Non Plan-104-Special Police -1327- Special Police Organisation" and "Demand No.1-2055-Police - Non Plan-001-D&A-1712-Introduction of Commissionerate system in the twin cities of Cuttack and Bhubaneswar".


