
The post of Law Officer in the rank of SDJM shall be filled up by way of deputation of an officer of equal rank from the Subordinate Judiciary.

The post of Accounts Officer shall be filled up in Class-II rank of OFS by way of deputation of an officer of equal rank from the Finance Department. Till an Officer of the Finance Department is deputed to the Commissionerate as Accounts Officer, the F.A. & C.A.O. of OSPH&W Corporation shall remain in charge of the post of Accounts Officer.

The charge is debitable to " Demand No.1-2055-Police-Non-Plan-001-D.&A.-1712-Introduction of Commissionerate System in the twin cities of Cuttack and Bhubaneswar.
