NOTIFICATION

Bhubaneswar, dated the 30.4.2012.
No.PDA-I-14/2012- 178 MM / D&A., In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in supersession of all previous notifications so far as it relates to the subject, the State Government do hereby declare establishment of a Traffic Police Station at Chandikhol in Jajpur district to be known as "**Chandikhol Traffic Police Station**" and define its local limits to the extent specified in column (2) of the Schedule below and direct that the said Traffic Police Station shall come into force on the date of publication of this notification in the Odisha Gazette.

Chandikhol Traffic Police Station	<p>(i) The stretch of road of NH – 5 owned and maintained by National Highway Authority of India from the beginning point of Nelia under Barachana Police Station up to Baitarane Bridge, Sathipur under Panikoili Police Station in the district of Jajpur.</p> <p>(ii) The stretch of road of N.H.-5(A) owned and maintained by National Highway Authority of India from Panchupandaba under Balichandrapur Police Station up to Chandikhol crossing under Barachana Police Station.</p> <p>(iii) The stretch of road of Express Highway-200 owned and maintained by National Highway Authority of India from Chandikhol under Barachana Police Station up to Brahmanipal Railway Crossing under Tomka Police Station.</p> <p>(iv) The stretch of road of N.H.-215 owned and maintained by National Highway Authority of India from Panikoili Chhaka under Panikoili Police Station up to Ragadi under Korei Police Station.</p>
