Sub:- Establishment of 5 (five) Marine Police Stations-creation of required posts.

Sir,

I am directed to convey the sanction of the Governor for creation of 405 (four hundred five) posts of different categories for the proposed Marine Police Stations each at Jambu in Kendrapara district, Fishing Harbour, Paradip in Jagatsinghpur district, Balaramgadi in Balasore district, Arjipati in Ganjam district and Dhamara in Bhadrak district in the scale of pay noted against each with usual D.A. and other allowances as sanctioned by the Government from time to time except in the case of Assistant Driver whose appointment are on contractual and consolidated remuneration basis. The posts are sanctioned from the dates those are actually filled up. All the posts sanctioned shall be part of the respective State or District cadre and shall be filled up accordingly.

4. The above posts are sanctioned pending issue of formal notification under section 2 (s) of Cr. P. C. for creation of aforementioned Police Stations. The State Police Headquarters shall take expeditious steps for submitting individual proposals for each Police Stations for issuing such notification in the prescribed manner enclosing the required information and documents.
