No. 44627/D&A. In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 ( 2 of 1974 ), the State Government do hereby declare the following five places to be the Special Police Stations for the purpose of registration, investigation, charge-sheeting etc. of the offences punishable under the Electricity Act, 2003 ( 36 of 2003 ) and other laws having their Headquarters as noted against each mentioned in column (3) and their territorial jurisdiction as noted against each mentioned in column (4) of the table below.
