In pursuance of Government of Odisha Home Department letter No.45178/SPS dt.22.11.2017 and as per the recommendation of the constituted Selection Committee, the following Inspector of Police as per his seniority in the gradation list is allowed to officiate as In-charge Deputy Superintendent of Police with following conditions.

1. The officer shall work as I/c DSP in the same scale of pay as she/he has been drawing as Inspector of Police.
2. The posting as I/c DSP shall not be treated as promotion.
3. The order to officiate as SDPO and DSP would be without any prejudice to the outcome of any Court cases pending in any Court of Law.




