



**OFFICE ORDER NO. 1421 /Pers.-II**

The case of ASI (Armed) Prasanna Kumar Paramanik of OSAP 6<sup>th</sup> Battalion, Cuttack (CSB Sl. No.25) was placed before the Central Selection Board for the year-2023 held on 26.07.2023. The CSB after scrutinizing his service record, decided to keep their recommendation in a sealed cover in pursuance of Govt. of Odisha, G.A. Department Office Memorandum No.3928/Gen. dtd.18.02.1994, as OSAP 1<sup>st</sup> Battalion, Dhenkanal Proceeding No.02/2022 was pending against him.

After conclusion of OSAP 1<sup>st</sup> Bn., Dhenkanal Prog. No.02/2022 by disciplinary authority with a minor punishment of "Censure in S.B." to Sri Prasanna Kumar Paramanik, ASI (Armed) vide B.O. No.1140, Dtd.26.07.2023, ASI (Armed) Prasanna Kumar Paramanik submitted a representation to S.P. Hdqrs., Cuttack for consideration of his promotion to S.I. of Police (Armed).

As per Orders of the DGP, the sealed cover containing findings of the CSB in respect of Prasanna Kumar Paramanik, ASI (Armed) of OSAP 6<sup>th</sup> Battalion, Cuttack (CSB Sl. No.25) was opened on 13.09.2023 and it is found that he has been selected by the CSB-2023 held on 26.07.2023 for promotion to the rank of S.I. of Police (Armed).

Having been selected by the Central Selection Board (CSB)-2023 held on 26.07.2023 for selection of ASIs (Armed) of Districts/Establishments/Battalions for promotion to the rank of S.I. of Police (Armed), ASI (Armed) Prasanna Kumar Paramanik is allowed promotion to the rank of S.I. of Police (Armed) retrospectively with effect from the date of his junior Sri Gajendra Kumar Sahoo was allowed promotion to the rank of Sub-Inspector of Police (Armed) vide State Police Hdqrs. Office Order No. 1324/Pers.-II, dtd.10.08.2023.

Accordingly, his seniority in the rank of S.I. of Police (Armed) is fixed in between, i.e. below Nursingha Charan Nanda of 6<sup>th</sup> IR, Bn., Khurda and above Gajendra Kumar Sahoo of OSAP 3<sup>rd</sup> Battalion, Koraput.

He will be paid the actual financial benefit in the rank of Sub-Inspector of Police (Armed) from the date he join the promotional post of Sub-Inspector of Police (Armed).

The promotional posting of the above officer will be issued later.

This issues with the approval of the DGP, Odisha.
