OFFICE ORDER NO. 981 /Pers-I, Dated 07.07.2023

The case of S.I. Sanjay Kumar Jena (CSB Sl.No.161 of 2021) of UPD, Bhubaneswar was placed before the CSB-2021 held at State Police Hdqrs. , Cuttack on 08.02.2021 for consideration of his promotion to the rank of Inspector of Police but the CSB after duly scrutinizing his service record did not select him for promotion to the rank of Inspector of Police due to his poor service record as adverse remarks recorded in his CCR for the period from 01.04.2019 to 31.02.2020. In the meantime, above adverse CCR remarks have been expunged by the DGP on 02.03.2023 communicated vide State Police Hdqrs. Memo No.114/ACR Cell dtd 02.03.2023.


After expunction of adverse CCR, S.I. Sri Jena has submitted representation with prayer for consideration of his retrospective promotion to the rank of Inspector of Police from the date his batch mates junior to him have been promoted vide S.P.Hdqrs. Office Order No.337/Pers.I dtd 29.04.2021. On consideration of his representation, DGP has been pleased to order to hold a Spl. CSB to review his case for retrospective promotion to the rank of Inspector of Police against CSB-2021.

After scrutinizing the service records and CCRs of S.I. Sanjay Kumar Jena of UPD, Bhubaneswar, the Review CSB found him suitable for retrospective promotion to the rank of Inspector of Police from 2021 i.e. from the date his batch mates junior to him, Ex. S.I. Prasanta Kumar Sahoo (CSB Sl. No.162) was allowed promotion to the rank of Inspector of Police vide S.P.Hdqrs. Office Order No.337/Pers.I dtd 29.04.2021. Accordingly his seniority in the rank of Inspector of Police is fixed above Inspector Ex.S.I. Prasanta Kumar Sahoo.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

His promotional posting will be decided by the Police Establishment Board.  
This issues with the approval of DGP.


