OFFICE ORDER No. 984 /Pers-I, Dated 07.07.2023

The case of S.I. Binod Kumar Rao (SC) (Spl. CSB Sl.No.174 of 2021) of Kalahandi district was placed before the Spl. CSB-2021 held at State Police Hdqrs. , Cuttack on 8/9.11.2021 for consideration of his promotion to the rank of Inspector of Police but the CSB after duly scrutinizing his service record did not select him for promotion to the rank of Inspector of Police as one major punishment i.e. forfeiture of increment for six months carrying the value of one Black Mark was at his credit which was imposed on him on 14.07.2020 in Kalahandi dist. prog. No. 08/2019. Besides, Kalahandi Dist. prog. No.02/21 and Kesinga PS case No.395 dtd 23.12.2019 U/s 394/341/323/506/ IPC were also pending against him.

Against the above major punishment of Black Mark with forfeiture of increment for six months , S.I. Binod Kumar Rao preferred an appeal before DIG of Police, SWR, Koraput. On consideration of his appeal petition, the DIG of Police, SWR, Koraput reduced the major punishment to "Censure in SB" vide Kalahandi district D.O.No.755 dtd 03.05.2022. Besides, Kalahandi dist. Proceeding No.02/2021 which was shown pending against him during Spl. CSB has also been disposed of by the S.P., Kalahandi by holding him not guilty of the charges vide Kalahandi D.O.No.307 dtd 04.03.2022. In Kesinga PS case No.395 dtd 23.12.2019 U/s 394/341/323/506 IPC, the final form as FR False vide F.F.No.197 dtd 28.06.2020 was submitted against him which was accepted by the Hon'ble JMFC, Kesinga vide Order No.08 dtd 18.8.2020.


Thereafter, his case was placed before the review CSB held on 07.07.2022 for considering his retrospective promotion to the rank of Inspector of Police . The Review CSB did not select him due to the adverse remarks recorded in his CCR for the period from 01.04.2015 to 20.03.2016 by S.P., Malkangiri. The adverse remarks for the above period have been expunged by the D.I.G. of Police, SWR, Koraput. As per orders of DGP, his case is placed before the present review CSB on 22.06.2023 for consideration.

After scrutinizing the nomination Rolls, CCRs and other records of S.I. Binod Kumar Rao, the Review Selection Board found him "suitable" for promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Rajendra Kumar Behera (CSB Sl. No.177 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 1079/Pers.I dtd 11.11.2021. Accordingly his seniority in the rank of Inspector of Police is fixed above Ex.S.I. Rajendra Kumar Behera now Inspector of Police .

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.


His promotional posting will be decided by the Police Establishment Board.
This issues with the approval of DGP.
