## NOTIFICATION

WHEREAS, Shri Sanjay Kumar Singh, IPS,(RR-1996) at present Dy Director General, Narcotics Control Bureau (NCB) has submitted a notice dated 29.02.2024 for acceptance of his voluntary retirement from Government service w.e.f. 30.04.2024 under Rule.16 (2) of AIS(DCRB)Rules,1958.

AND WHEREAS, sub-Rule (2) of Rule 16 of AIS (DCRB) Rule,1958 provides that a member of Service may after giving at least 3(three) months previous notice in writing to the State Government to retire from service on the date on which such member completes 30 (thirty) years of qualifying service or attains 50(fifty) years age or on any date thereafter.

AND WHEREAS, the date of birth and date of entry into Indian Police Service of Shri Sanjay Kumar Singh, IPS being 08.01.1965 and 05.09.1996 respectively, he has attained 59(fifty nine) years of age and completed 27(twenty Seven) years of qualifying service. So, Shri Sanjay Kumar Singh, IPS is eligible to retire from Government service voluntarily under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958.

AND WHEREAS, the State Government are empowered under Rule 16 (2) of AIS (DCRB) Rule, 1958 to accept the notice for voluntary retirement of the IPS officers belonging to the State cadre concerned and as per second proviso to Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958, the State Government concerned on a request made by the member of service may relax the mandatory period of 3 (three) months previous notice.

AND WHEREAS, in exercise of the powers conferred on them under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958, the State Government have been pleased to relax the mandatory notice period of three months in case of Shri Sanjay Kumar Singh, IPS for his voluntary retirement from Government Service.

NOW THEREFORE Shri Sanjay Kumar Singh, IPS at present Dy Director General, NCB is allowed to retire voluntarily from the Indian Police Service under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rules, 1958 w.e.f. 30.04.2024. He will be entitled to all retirement benefits as per rule under AIS (DCRB) Rule,
