The case of Sri Suraj Prakash Rout, Assistant Section Officer of State Police Hdqrs., Cuttack along with other eligible ASOs were placed before the Departmental Promotion Committee for the year-2021 held on 31.12.2020 for consideration of their promotion to the rank of Section Officer. The findings of the DPC in respect of Sri Rout, ASO was kept in individual sealed cover due to pendency of State Police Hdqrs., Proceeding No.01/2020 against him in pursuance of G.A. Department Office Memorandum No.3928/Gen., dtd.18.02.1994 and No.29699/Gen., dtd.01.11.1997. The State Police Headquarters Proceeding No. 01/2020 which was pending against Sri Rout has been dropped by the DGP, Odisha in the meantime basing on the findings of the Enquiring officer vide State Police Headquarters O.D No. 22862/Min dt.10.06.2022 with a caution to the charged officer. Accordingly, a caution letter has been issued to the charged officer vide State Police Headquarters, Cuttack Letter No.22863/Min. dated.10.06.2022.

Thereafter, on consideration of the representation of Sri Suraj Prakash Rout, ASO for his retrospective promotion to the rank of Section Officer, DGP was pleased to pass order to open the sealed cover in pursuance of G.A. Department Office Memorandum No.3928/Gen., dtd.18.02.1994 & No.29699/Gen., dtd.01.11.1997. Accordingly, the sealed cover has been opened on 05.07.2022 and found that he was selected by the DPC, 2021 for promotion to the rank of Section Officer.


Having been selected by the Departmental Promotion Committee held on 31.12.2020, Sri Suraj Prakash Rout (DPC Sl. No.19), Assistant Section Officer of State Police Hdqrs., Cuttack is promoted to the rank of Section Officer retrospectively with effect from the date of his immediate junior Smt. Soudamini Das (DPC Sl. No.20) Asst. Section Officer of O/o the Supdt. of Police, CID, CB, Odisha, Cuttack got promotion to the rank of Section Officer vide S.P., Hdqrs., Office Order No.77/Min., dtd.29.01.2021.

The pay of Sri Rout will be fixed notionally in the time scale of higher grade with effect from the date of his immediate junior Smt. Das got promotion to the rank of Section Officer. He will not be eligible for any arrear financial benefits for the period he has not actually worked in the higher post/grade.

On such promotion, he is posted to State Police Headquarters, Cuttack (Pers.-II Section) in an existing vacancy.

This issues with the approval of DGP.




