The Hon'ble OAT vide order dated 12.01.2018 in O.A.No.667/2017 filed by Prasanna Kumar Nayak –vrs- State of Odisha and others and similar batch of cases and order dated 30.4.2018 in O.A.No.1217(C)/2017 filed by Banoj Kumar Naik –vrs- State of Odisha and others and similar batch of cases have quashed State Police Hdqrs. Office Order No. 231/Board dtd 21.4.2017, Office Order No.237/Board dtd 25.4.2017, Office Order No.581/Pers.I dtd 16.8.2017 and directed to send the applicants to undergo ASI's course of training as per relevant rules whenever their turn comes. In implementing the above orders of Hon'ble OAT, the following Constables (reverted OASIs vide State Police Hdqrs. Office Order No.581/Pers.I dtd 16.8.2017) are hereby allowed to officiate as OASIs in their respective districts/Estts. as mentioned against each with immediate effect. If they have been transferred to other Dists./Estts. the concerned Dists./Estts. may allow them to officiate as ASI of Police in their Dists./Estts. The Constables are allowed to officiate as OASIs as per availability of the vacancies.

Pending passing the final training examination, they will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr. P.C. during the officiating period as Officiating ASI of Police. On the basis of the results of the final examination, their inter-se-seniority will be determined according to the marks obtained by them in the final examination. In case more than one candidate will secure equal marks, the names will be arranged according to their relative seniority in the feeder grade. Their seniority in the rank of ASI shall be reckoned from the date of passing the final examination in ASIs' course of training. If they fail in the final examination, they will be allowed two more chances to clear the failed subjects. In the event of failure to clear the failed subjects in two successive attempts, he/she shall be reverted to the substantive rank i.e. the rank held immediately prior to his/her officiating as ASI

of Police. The annual increments shall not be allowed unless and until the aforesaid examination is passed by the officiating ASIs' of Police.

The Constable should not be allowed to officiate as OASIs if any vigilance case/criminal case/departmental proceedings is pending against him, if he is under suspension or if he is awarded major penalty after 01.07.2016.
