OFFICE ORDER No. 1486 /Pers-I, Dated 26 .10.2023

The case of S.I. Ranjit Kumar Seth (SC) (CSB SI.No.207 of 2019) of Vigilance, Cuttack was placed before the CSB-2019 held at State Police Hdqrs., Cuttack on 19.06.2019 for consideration of his promotion to the rank of Inspector of Police but the findings of the CSB regarding his promotion was kept in individual sealed cover due to pendency of Cuttack UPD Proceeding No.31/2018 & 10/2019. As intimated by the DCP, Cuttack vide his letter No.2810/RO dtd 25.05.2023, Cuttack UPD Proceeding No. 31/2018 has been disposed of vide D.O.No.295 dtd 02.02.2021 with a minor punishment i.e. "Censured in SB" and also Cuttack UPD Prog.No. 10/2019 has already been dropped vide D.O.No.1256 dtd 25.03.2019. On conclusion of the above proceeding, SI Ranjit Kumar Seth submitted a representation for consideration of his retrospective promotion to the rank of Inspector of Police. As per orders of DGP, the sealed cover in respect of SI Ranjit Kumar Seth of CSB 2019 held on 19.06.2019 was opened and found that he was not selected by the CSB due to adverse remarks recorded in his CCR for the period from 07.07.2017 to 31.03.2018. Later, the DGP has been pleased to expunge the adverse remarks of the above period recorded in his CCR and ordered that the over all grading for the period shall be taken as Average Officer without any adverse connotation.

Thereafter, SI Sri Seth had represented for consideration of his retrospective promotion to rank of Inspector of Police from the date his junior Ex. S.I. Kaibalya Seth (CSB SI. No.208) got promotion vide S.P.Hdqrs. Office Order No.626/Pers.I dtd 26.06.2019. On consideration of his representation, DGP has been pleased to order to hold a review CSB to consider his retrospective promotion to the rank of Inspector of Police.

Having been selected by the Review CSB held on 20.10.2023, S.I. Ranjit Kumar Seth is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Kaibalya Seth (SC) (CSB SI. No.208 of CSB 2019) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 626/Pers.I dtd 26.06.2019. Accordingly his seniority in the rank of Inspector of Police is fixed above Ex.S.I. Kaibalya Seth now Inspector of Police.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

On such promotion, he is posted to **Vigilance Directorate** pending approval by Police Establishment Board.

This issues with the approval of DGP.
