The case of S.I. Rabindra Kumar Sahoo (CSB SI.No.155 of 2021) of Angul district was placed before the Spl. CSB-2021 held at State Police Hdqrs., Cuttack on 27.05.2022 for consideration of his promotion to the rank of Inspector of Police but the findings of the CSB regarding his promotion was kept in individual sealed cover due to pendency of Dhenkanal district Proceeding No.14/2019 against him. On conclusion of the above proceeding, he was awarded with one Black Mark by the DIG of Police, NCR, Talcher, the same was published vide Dhenkanal D.O.No.1114 dtd 16.07.2022. Then he submitted an appeal petition before DGP against the punishment awarded by DIGP, NCR, Talcher. Considering his appeal petition, DGP has been pleased to set aside the punishment of "One Black Mark " and instead awarded him a minor punishment of "Censured in SB" vide order dtd 01.06.2023.

Thereafter, SI Rabindra Kumar Sahoo submitted a representation for consideration of his retrospective promotion to the rank of Inspector of Police. As per orders of DGP, the sealed cover containing the findings of the Spl.CSB for the year 2021 in respect of him was opened on 25.10.2023 and found that he has been selected by the Spl. CSB for the year 2021 held on 27.05.2022.


Having been selected by the Spl. CSB-2021 held on 27.05.2022, S.I. Rabindra Kumar Sahoo is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Sushama Pasayat (CSB SI. No.157 of Spl. CSB 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 561/Pers.I dtd 06.06.2022. Accordingly his seniority in the rank of Inspector of Police is fixed above Ex.S.I. Sushama Pasayat now Inspector of Police.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

On such promotion, he is posted to **Rourkela Police district** pending approval by Police Establishment Board.

This issues with the approval of DGP.
