The case of S.I. Suprava Nayak (Spl. CSB SI.No.129 of 2021) of SCRB, Bhubaneswar was placed before the Spl. CSB-2021 held at State Police Hdqrs. , Cuttack on 27.05.2022 for consideration of her promotion to the rank of Inspector of Police but the Spl. CSB after duly scrutinizing her service record did not consider for promotion to the rank of Inspector of Police, as she was on sick for a long time since 21.11.2020.

After joining in duty, S.I. Suprava Nayak has submitted a representation to DGP requesting for consideration of her promotion to the rank of Inspector of Police from the date her juniors have been promoted to the rank of Inspector of Police.

After scrutinizing the nomination Rolls, CCRs and other records of S.I. Suprava Nayak for the preceding 5 years to the CSB-2021, the Spl. CSB held on 27.04.2023 found her "suitable" for promotion to the rank of Inspector of Police.

Having been selected by the Spl. CSB held on 27.04.2023, S.I. Suprava Nayak is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date her immediate junior Ex. S.I. Panchanan Mohanty (Spl. CSB SI. No.131 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 561/Pers.I dtd 06.06.2022. Accordingly her seniority in the rank of Inspector of Police is fixed above Inspector Ex.S.I. Panchanan Mohanty.

Her pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of her immediate junior was allowed promotion to the rank of Inspector of Police. She is not entitled to any financial benefits for the period as she has not actually worked in the higher grade post.

Her promotional posting will be decided by the Police Establishment Board.  
This issues with the approval of DGP.
