The case of S.I. Ashisdev Sahoo (CSB SI.No.137 of 2021) of CID,CB, Odisha, Cuttack was placed before the CSB-2021 held at State Police Hdqrs. , Cuttack on 8/9.11.2021 for consideration of his promotion to the rank of Inspector of Police due to his poor service record i.e. adverse CCR for the period 2018-2019 which was coming during preceding five years to the CSB-2021. Later the adverse remarks recorded in the CCR of S.I. Sri Sahoo for the period from 01.04.2018 to 20.02.2019 has been expunged by the DGP, Odisha on 16.05.2023 with comments that his overall grading shall be taken as "Average" with no adverse comments.

Thereafter, he has submitted a representation to DGP for retrospective promotion from the year 2021 from the date of his juniors have been promoted to the rank of Inspector of Police.

After scrutinizing the nomination Rolls, CCRs and other records of S.I. Ashisdev Sahoo, the Spl. CSB held on 27.04.2023 found him "suitable" for promotion to the rank of Inspector of Police.

Having been selected by the Spl. CSB held on 27.04.2023, SI Ashisdev Sahoo is allowed promotion to the rank of Inspector of Police retrospectively from the year 2021 with effect from the date his immediate junior Ex. S.I. Suchitra Parida (CSB SI. No.138 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 234/Pers.I dtd 30.03.2022. Accordingly his seniority in the rank of Inspector of Police is fixed above Ex.S.I. Suchitra Parida now Inspector of Police.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period as he has not actually worked in the higher grade post.

His promotional posting will be decided by the Police Establishment Board.

This issues with the approval of DGP.
