The case of Shri Narayan Nayak, ASI(Communication) of Signals Establishment (CSB Sl. No.11) was placed before the Central Selection Board for the year 2023 convened on 08.05.2023 for determining his promotion to the rank of SI(Communication). At the time of CSB, ASI(Communication) Narayan Nayak had not submitted his property statement for the year 2022 in HRMS portal which is a prerequisite for promotion and within the preceding 5 years of the CSB, 2023. The Central Selection Board after duly scrutinizing his service record did not consider his case for promotion to the rank of SI (Communication) in Signals Establishment for the year 2023, in pursuance of GA & PG Department Notification No.16105/Gen, dated:24.06.2021.

The Government of Odisha vide GA & PG (CSE) Department letter No.659/SE, dated:24.5.2023 has extended the time limit up to 30.06.2023 for submission of property statement for the year 2022. In pursuance of the above Government order dated:24.05.2023, ASI(Communication) Narayan Nayak has submitted his property statement on 25.05.2023 for the year 2022.

In the meantime, the Government of Odisha vide GA & PG Department letter No.17429/Gen., dated:19.06.2023 has instructed that the property statement by the defaulting Government Servant with reference to GA & PG (SE) Department letter No.659/SE, dated:24.05.2023 shall be taken into consideration at the time of consideration of promotion of the respective employee by convening review DPC / Regular DPC wherever applicable and their seniority in the respective ranks may be restored accordingly.

Upon consideration of the representation, ASI (Communication) Narayan Nayak of Signal Establishment to allow him retrospective promotion to SI (Communication), DGP has been pleased to pass order for convening a review CSB to consider the case of ASI (Communication) Narayan Nayak of Signals Establishment for retrospective promotion to SI (Communication).

After scrutinizing the service records of ASI(Communication) Narayan Nayak of Signals Establishment, the Spl. CSB held on 08.08.2023 found him suitable for promotion to the rank of SI (Communication) retrospectively from the date his immediate junior Maheswar Gochhi, ASI (Communication) (CSB Sl.No.12) of CSB – 2023 was promoted to the rank of SI (Communication).

Accordingly, Shri Narayan Nayak ASI(Communication) of Signals Establishment is allowed promotion to the rank of SI(Communication) retrospectively with effect from the date his junior Maheswar Gochhi, ASI (Communication) (CSB Sl.No.12) of CSB – 2023 was allowed promotion to the rank of SI (Communication) vide State Police Hdqrs. Office Order No.784/Pers-II, Dated:17.05.2023.

His seniority in the rank of SI (Communication) is fixed above Ex-ASI (Communication) Shri Maheswar Gochhi accordingly.

His pay will be fixed notionally in the time scale of pay of SI (Communication) from the date of his immediate junior was allowed promotion to the rank of SI (Communication). He is not entitled to any financial benefits for the period he has not actually worked in the higher grade/ post.

The selection of Shri Narayan Nayak ASI(Communication) for promotion to the rank of S.I.(Communication) shall be subject to the result of the W.P.(C) No.1505/2020 filed by Shri Basudev Sahu and 9 other A.S.Is. (Communication) as per interim order No.3 dated:16.01.2020 passed by the Hon'ble High Court, Orissa in I.A. No.603/2020 arising out of W.P.(C) No.1505/2020.

His promotional posting will be decided by the Range Police Establishment Board of Signal Establishment.
