**OFFICE ORDER NO. 160 /Pers.-II dtd. 17.02.2023**

In Pursuance to the order No.01 dtd. 26.09.2022 of the Hon'ble High Court of Odisha in W.P(C) (OAC) No.192 of 2019 filled by Sri Dinesh Kumar Sahoo, Ex- Sergeant (now S.I of Police (Armed) of Puri District and as per Home Department letter No.43405/FSS & IE dtd.15.12.2022, Sri Dinesh Kumar Sahoo, Ex- Sergeant (now S.I of Police (Armed) has been selected by the Special Central Selection Board held on 14.02.2023 for retrospective promotion to the rank of R.I. of Police (Now renamed as Inspector of Police (Armed) notionally from the year-2018.


As such, Ex-Sergeant Sri Dinesh Kumar Sahoo (now S.I of Police (Armed) is allowed promotion to the rank of R.I. of Police (Now renamed as Inspector of Police (Armed) notionally with retrospective effect and his seniority is fixed above Ex- Sergeant Biren Kumar Behera who was promoted to the rank of R.I. of Police (Now renamed as Inspector of Police (Armed) retrospectively from the year-2018 vide State Police Hdqrs. Office Order No.847/Pers.-II dtd.14.09.2022 being selected by the Spl. CSB held on 29.08.2022.

His pay in the rank of Inspector (Armed) shall be fixed notionally from the date his senior Shri Dillip Kumar Behera (SC) was promoted to the rank of R.I. of Police (Now renamed as Inspector of Police (Armed)). He will be paid the actual financial benefit from the date he joined in the promotional post.

The promotional posting will be decided later by the "Transfer Committee Meeting". His promotion will be effective from the date of joining in the promotional post.
