OFFICE ORDER NO. 197 /Pers-I

The case of Sri Nityananda Mantri, Ex. ASI of Police of Subarnapur district (Now Retired) was placed before the Central Selection Board for the year-2011 held on 18.07.2011 for his selection for promotion to the rank of Sub Inspector of Police. Since, Sri Mantri was placed under suspension w.e.f. 12.07.2011, the CSB kept their finding in sealed cover as per provisions of G.A. Department Office Memorandum No. 3928/Gen, dtd. 18.02.1994.

Subsequently, Subarnapur District Prog. No. 07/2011 was drawn up against Sri Nityananda Mantri. After due enquiry, the Disciplinary Authority had imposed Major Punishment of one Black Mark upon Sri Mantri. He then preferred an appeal before the D.I.G. of Police, NR, Sambalpur who upheld the order of major punishment imposed by the Disciplinary Authority. Subsequently, Sri Mantri submitted a revision petition before the D.G. & I.G. of Police. His revision petition was considered by the DGP and he was exonerated from the charges and his suspension period was treated as duty. The order passed by DGP was published vide Subarnapur DO No. 1232, dtd. 11.12.2012.

In the meantime, Sri Mantri has retired from Government Service on superannuation pension wef 30.11.2012. Being exonerated of the charges leveled against him, Sri Mantri had filed representation before the authorities to consider his case for promotion to the rank of Sub Inspector of Police with retrospective effect from 18.07.2011 i.e. from the date his juniors were promoted to the rank of Sub Inspector of Police. As he was retired from Government Service by that time, he had no scope to undergo DCSI Course of Training. Hence, his representation could not be considered for promotion to the rank of Sub Inspector of Police.

On consideration of grievance petition of Sri Mantri, Home Department vide their letter No. 13673/D&A, dtd. 19.04.2016 instructed that it has been decided to appoint Sri Mantri notionally to the rank of Sub Inspector of Police from the date his juniors were appointed to the rank of Sub Inspector of Police. He will not be given annual increment as he has no scope to undergo training, as he has retired from Govt. service on 30.11.2012 on attaining the age of superannuation.

As the matter stood thus, Sri Mantri filed WPC(OAC) No. 2575/2016 and the Hon'ble High Court vide their Order dated 07.07.2022 directed the Additional Chief Secretary

to Government, Home Department to consider the case of the petitioner in accordance with law.


Keeping in view of the Order dated 07.07.2022 of the Hon'ble High Court passed in WPC (OAC) No. 2575 of 2016, orders communicated by Home Department in their OSWAS File No. PT1-HOME-DA1-CASE1-0540-2021 and Home Department letter No. 13673/D&A, dtd. 19.04.2016, D.G. & I.G. of Police has been pleased to pass order for opening the sealed cover of the CSB-2011 in respect of Sri Mantri.

The sealed cover was opened by the A.I.G. of Police, Personnel on 09.02.2023, and found that Sri Mantri had been selected for promotion to the rank of Sub Inspector of Police by the CSB of 2011.

Having been selected by the CSB held on 18.07.2011, Ex. ASI of Police Nityananda Mantri (Now Retired) is allowed notional promotion to the rank of S.I of Police with retrospective effect from 18.07.2011 from the date his batch mates were allowed promotion. His pay shall be fixed notionally in the rank of Sub Inspector of Police wef 18.07.2011. However, he will not be entitled for actual financial benefit or annual increment as he had no scope to undergo DCSI Course of Training till his date of retirement i.e. 30.11.2012.
