The case of S.I. Binayak Dwibedy (CSB Sl.No.51 of 2016) of Office of the Director of Mines & Geology, Bhubaneswar was placed before the Central Selection Board held at State Police Hdqrs., Cuttack for consideration of his promotion to the rank of Inspector of Police for the year 2013, 2014, 2016, 2017, 2019, 2020, 2021 & 2022 respectively. But the findings of the above said CSBs were kept in sealed covers due to the pendency of Sambalpur Vigilance PS case No.42/2009 as well as Sundargarh district Proceeding No.02/2010 against him.

After disposal of the above vigilance case (acquitted) as well as Sundargarh district Proceeding(not guilty), he submitted representation for consideration of his promotion to the rank of Inspector of Police retrospectively from the date his immediate junior was allowed promotion to the rank of Inspector of Police.

As per orders of DGP, the sealed covers of the CSBs was opened on 15.12.2023 and it is found that SI Binayak Dwibedy has been selected by the CSB for the year 2016 for promotion to the rank of Inspector of Police.

Having been selected by the CSB, S.I. Binayak Dwibedy is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Sanjay Kumar Parida (CSB Sl. No.59 of 2016) was allowed promotion to the rank of Inspector of Police. Accordingly his seniority in the rank of Inspector of Police is fixed above Ex.S.I. Sanjay Kumar Parida now Inspector of Police.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

His promotional posting will be decided by the Police Establishment Board.

His promotion is subject to the final outcome of WP(C) No. 35670/2023 filed by Rakesh Kumar Behera and others & WP(C) No. 36255/2023 filed by Umesh Chandra Sahoo & Others –Vrs-state of Odisha & Others.

This issues with the approval of DGP.
