The case of S.I. Madan Mohan Naik (SC) (CSB Sl.No.26 of 2013) of Keonjhar district, was placed before the CSB-2023 held at State Police Hdqrs., Cuttack on 11.12.2023 for consideration of his promotion to the rank of Inspector of Police. The CSB after scrutinizing his service record did not found him suitable for promotion to the rank of Inspector of Police due to his poor service record, as his CCR being recorded as adverse from 01.04.2016 to 31.03.2017.

Thereafter, SI Sri Naik had represented for consideration of his retrospective promotion to the rank of Inspector of Police citing the fact that he had an adverse remarks in his CCR for the year 2016-17 which had already been expunged by the DIG of Police, WR, Rourkela vide order dtd 28.05.2021.

On consideration of his representation, Review CSB was held on 11.12.2023. Having been selected by the Review CSB held on 11.12.2023, S.I. Madan Mohan Naik is allowed promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Mrunal Kalo (ST) (CSB SI. No.42 of CSB 2023) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 1556/Pers.I dtd 16.11.2023. Accordingly his seniority in the rank of Inspector of Police is fixed above Ex.S.I. Mrunal Kalo now Inspector of Police.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

His promotional posting will be decided by the Police Establishment Board.

His promotion is subject to the final outcome of WP(C) No. 35670/2023 filed by Rakesh Kumar Behera and others & WP(C) No. 36255/2023 filed by Umesh Chandra Sahoo & Others – Vrs- state of Odisha & Others.
