The case of Sri Jitendra Kumar Senapaty, Assistant Section Officer of State Police Hdqrs., Cuttack along with other eligible ASOs were placed before the Departmental Promotion Committee for the year-2021 held on 31.12.2020 for consideration of their promotion to the rank of Section Officer. The findings of the DPC in respect of Sri Senapaty, ASO was kept in individual sealed cover due to pendency of State Police Hdqrs., Proceeding No.05/2017 against him in pursuance of G.A. Department Office Memorandum No.3928/Gen., dtd.18.02.1994 and No.29699/Gen., dtd.01.11.1997. On conclusion of the above proceeding, Sri Senapaty, ASO was awarded with a minor punishment of "withholding of one increment for six months" by the then DGP which was communicated vide SP, Hdqrs., Memo No.47387/Min., dtd.31.12.2021.

Thereafter, on consideration of the representation of Sri Jitendra Kumar Senapaty, ASO for his retrospective promotion to the rank of Section Officer, DGP was pleased to pass order to open the sealed cover in pursuance of G.A. Department Office Memorandum No.3928/Gen., dtd.18.02.1994 & No.29699/Gen., dtd.01.11.1997. Accordingly, the sealed cover has been opened on 21.03.2022 and found that he was selected by the DPC, 2021 for promotion to the rank of Section Officer.


Having been selected by the Departmental Promotion Committee held on 31.12.2020, Sri Jitendra Kumar Senapaty (DPC Sl. No.12), Assistant Section Officer of State Police Hdqrs., Cuttack is promoted to the rank of Section Officer retrospectively with effect from the date of his immediate junior Sri Sanjeeb Kumar Pradhan (DPC Sl. No.13) Asst. Section Officer of Vigilance, Cuttack who got promotion to the rank of Section Officer vide S.P., Hdqrs., Office Order No.77/Min., dtd.29.01.2021.

The pay of Sri Senapaty will be fixed notionally in the time scale of higher grade with effect from the date of his immediate junior Sri Pradhan got promotion to the rank of Section Officer. He will not be eligible for any arrear financial benefits for the period he has not actually worked in the higher post/grade.

On such promotion, he is posted to State Police, Hdqrs., Cuttack (Confidential Section) in an existing vacancy.

This issues with the approval of DGP.
