OFFICE ORDER NO. 214 /Pers.-II dtd. 26.02.2024

The case of S.I. of Police (Armed) Anil Kumar Mukhi (SC) (Sl. No.12 of CSB-2023) of Sambalpur district was placed before the Central Selection Board-2023 held at State Police Hdqrs., Cuttack on 07.07.2023 for consideration of his promotion to the rank of Inspector of Police (Armed). The findings of the CSB was kept in a sealed cover in pursuance of G.A. & P.G. Department Office Memorandum No.3928/Gen. dtd.18.02.1994 and subsequent amendment made to it, as Sambalpur district proceeding No.09/2023 was pending against him during the last five years of the CSB-2023. In the said proceeding he has been exonerated and the proceeding has been dropped vide Sambalpur D.O. no.55 dtd. 08.01.2024. After disposal of the above proceedings, S.I. of Police (Armed) Anil Kumar Mukhi submitted a representation to DGP for consideration of his retrospective promotion to the rank of Inspector of Police (Armed) from the date when his junior got such promotion from the year-2023.


The matter was examined at State Police Hdqrs., Cuttack and placed before the DGP. As per orders of the DGP, the above sealed cover of the CSB was opened on 12.02.2024, and it is found that S.I. of Police (Armed) Anil Kumar Mukhi (SC) (Sl. No.12 of CSB-2023) of Sambalpur district was selected by the CSB for the year-2023 held on 07.07.2023 for promotion to the rank of Inspector of Police (Armed).

In view of the above, S.I. of Police (Armed) Anil Kumar Mukhi (SC) of Sambalpur district is allowed promotion to the rank of Inspector of Police (Armed) retrospectively with effect from the date of his immediate junior Ex- S.I. of Police (Armed) Hemanta Kumar Bilung (S.T.) (Sl. No.13 of CSB-2023) was allowed promotion to the rank of Inspector of Police (Armed) vide State Police Hdqrs. Office Order No. 1037/Pers.-II dtd.14.07.2023. Accordingly, his seniority in the rank of Inspector of Police (Armed) is fixed above Ex- S.I. of Police (Armed) Hemanta Kumar Bilung (S.T.).

His pay will be fixed notionally in the time scale of pay of Inspector of Police (Armed) from the date of his immediate junior was allowed promotion to the rank of Inspector of Police (Armed). He is not entitled to get any financial benefit for the period he has not actually worked in the higher grade/post.

His posting will be decided by the "Transfer Committee Meeting".  
This issues with the approval of DGP.
