Following Inspectors of, Police of Odisha Police are attached to SIT, CBI, Bhubaneswar vide State Police Headquarters Office Orders as noted against each. As the General Election to Lok Sabha and Odisha Legislative Assembly will be held in April-2019 in the state of Odisha, there is requirement of Officers in the rank of Inspector of Police for proper maintenance of Law and Order in the State and for providing adequate number of Police Officers at the Police Station level.
