If, at any time after appointment of a Meritorious Sportsperson under these rules, the particular sporting achievement for which the Sportsperson gets appointment is declared as void or derecognised by the competent National or International Sporting Association for the Sportsperson failing in dope test or for any other reason, the service of the Sportsperson concerned shall be terminated after considering his/her show cause reply on merit and giving him/her reasonable opportunity to defend his/her case.

The category as against which the candidates have been selected for appointment as mentioned against each may be entered in their Service Books and they will be counted against their respective categories for all purpose.


