The case of Sri Jambeswar Pati, Senior Clerk of DPO, Puri was placed before the Departmental Promotion Committee held on 26.11.2020 for consideration of his promotion to the rank of Head Clerk. The findings of the DPC in respect of Sri Pati, Senior Clerk was kept in individual sealed cover due to pendency of Puri District Proceeding No.10/2018 in pursuance of G.A. Department Office Memorandum No.3928/Gen., dtd.18.02.1994. The proceeding was disposed off with a Minor Punishment i.e. Censured in SB by the I.G. of Police, CR, Cuttack.

Thereafter, basing on the representation of Senior Clerk, Sri Jambeswar Pati, Senior Clerk of DPO, Puri for his retrospective promotion, DGP, Odisha was pleased to pass order for opening of the sealed cover in pursuance to the G.A. Department Office Memorandum Office Memorandum No.3928/Gen., dtd.18.02.1994 and No.29699/Gen., dtd.01.11.1997. Accordingly, the sealed cover was opened on 16.04.2024 and found that Sri Pati was selected by the DPC, 2020 for promotion to the rank of Head Clerk.

Having been selected by the Departmental Promotion Committee held on 26.11.2020, Sri Jambeswar Pati, Senior Clerk of DPO, Puri is promoted to the rank of Head Clerk retrospectively with effect from the date his junior Sri Debendra Das, Sr.Clerk of Police Commissionerate got promotion to the rank of Head Clerk vide State Police Hdqrs., Cuttack Office Order No.832/Min., dtd. 27.11.2020.

The pay of Sri Pati will be fixed notionally in the time scale of higher grade with effect from the date his junior Sri Das got promotion to the rank of Head Clerk. He will not be eligible for any arrear financial benefits for the period he has not actually worked in the higher post/grade.

On such promotion, he is posted to DPO, Nayagarh in an existing vacancy.
