OFFICE ORDER NO. 372 /Pers.I DTD. 02-05-2024

The case of ASI Dillip Kumar Dash of Deogarh district for consideration of his promotion to the rank of S.I. of Police was placed before the CSB for the year 2021, 2022 and 2023 respectively. The Central Selection Board after scrutinizing his service record decided to keep their recommendations in a sealed cover in pursuance of G.A. Deptt. Office Memorandum No.3928/Gen. dtd 18.02.1994, as Cuttack Vigilance PS case No.71/2011 was pending against him.


ASI Sri Dash has submitted a representation for consideration of his promotion to the rank of S.I. of Police as he has been acquitted in Cuttack Vigilance PS case No. 71/2011 by the Hon'ble Court of Addl. District and Session-cum-Spl. Judge, Vigilance, Angul vide order dtd 27.01.2023 being found not guilty of the charges.

The matter was examined at State Police Hdqrs., Cuttack and placed before DGP. As per orders of DGP, the sealed covers containing the recommendation of the CSBs in respect of ASI Dillip Kumar Dash was opened on 21.03.2024 and found that he has been selected by the CSB for the year 2023 for promotion to the rank of Sub-Inspector of Police.

Having been selected by the CSB, 2023 held on 13.04.2023, ASI Dillip Kumar Dash (CSB Sl. No. 42) of Deogarh district is allowed promotion to the rank of Sub-Inspector of Police with effect from the date of his joining at training centre for undergoing DCSI course of training in next available batch for a period of six months as per Home Deptt. Notification No.4888/D&A dtd 5.2.2021. His seniority in the rank of Sub-Inspector of Police on promotion is fixed above his immediate junior S.I. Debarchan Kalet (SC) (CSB Sl. No. 54) of Jharsuguda district who was allowed promotion to the rank of Sub-Inspector of Police vide State Police Hdqrs. Office Order No.524/Pers.I dtd 24.04.2023 being selected by the CSB -2023 held on 13.04.2023


