In pursuance to Odisha Staff Selection Commission Notification No.364/OSSC, dtd.20.01.202, Miss Soumya Mohanty is hereby appointed temporarily as Sub-Inspector of Police, Handwriting Bureau, CID, CB in UR Category on contractual basis as "Initial Appointees" as per Odisha Group-B posts (Contractual Appointment) Rule, 2013 read with Odisha Group-B posts (Contractual Appointment) Amendment Rules, 2021 vide G.A. Department Notification No.28626/Gen. dtd.27.10.2021 in the Pay Band of Rs. 9300 - 34800/- with Grade Pay 4200/-. During the period of initial appointment, she will draw her monthly remuneration at the rates prescribed as per G.A. Department Notification No.28626/Gen. dtd.27.10.2021, with effect from the date of her joining.

Her appointment is subject to re-verification of original certificate of age, caste/category, educational qualification and medical fitness certificate issued by an authorized Government Doctor.

Appointment of Miss Soumya Mohanty is purely temporary and can be terminated at any time without assigning any reason thereof.


She will undergo short course of training for a period of 03 (three) months at the designated Police Training Institutions and Post Graduate Diploma Course in Document Examination at Lok Nayak Jayaprakash Narayan National Institute of Criminology and Forensic Science, New Delhi as decided from time to time.

She should execute a bond on her joining at Police Training Institutions. She should be fit to attend the training. Any report from a doctor declaring her unfit to undergo lessons for any length of time will make her liable for being discharged from service. She is liable to be discharged at any stage of her training career, if she is found to be unsatisfactory/ unsuitable or fails to complete the course successfully or she otherwise render herself undesirable.

Her inter-se seniority in the rank of S.I. of Police, Handwriting Bureau will be determined as per Home Department Notification No.46530, dtd.21.12.2016.

She should report her joining on **10.05.2022** in the Office of the Addl. D.G of Police, CID CB, Odisha, Cuttack. If she fails to join on the aforementioned date without assigning satisfactory reason, her appointment will stand cancelled. She will be under probation for a period of 02 years. During that period, she may be terminated, if her work and conduct is found unsatisfactory.






