In pursuance to Order No.04 dtd 21.02.2023 passed by Hon'ble High Court of Orissa in W.P.C. (OAC) No.147 of 2019 and Odisha Staff Selection Commission Notification No. 4093/OSSC dtd 13.10.2023, **Miss Jyotirmayee Tripathy** (UR) (Women) is hereby appointed temporarily as Sub-Inspector of Police - 2015 on regular basis with basic pay of Rs.35400/- per month (Cell-1 of Level-9) in ORSP Rule 2017 with usual D.A. and other Allowances as admissible from time to time with effect from the date of her joining.

On appointment, she is posted to **Puri** district.

2. Her appointment is subject to

2.1 Re-verification of original certificates with respect to proof of age, caste, category & educational qualification and verification of her character and antecedents.

2.2 Submission of a medical fitness certificate issued by an authorized Govt. Medical Officer.

2.3 Submission of formal Relieve Order of resignation from service issued by previous employer of any Government/ PSU/ State PSU/ Govt. funded autonomous bodies etc., if she is employed in Government/ PSU/ State PSU/ Govt. funded autonomous bodies etc.

3. Her appointment is purely temporary and can be terminated at any time without assigning any reasons thereof.

4. She shall be on probation for a period of two years from the date of her joining or date of passing Final Examination of Sub- Inspector's course of Training whichever is later in terms of Rule 22 of Home Department Notification No. 4888/D&A dt. 05.02.2021.

5. She will report before the **Supdt. of Police, Puri** on **<u>29th January, 2024</u>**. On reporting, she will submit her Joining Report in the format enclosed as *Annexure- A*.

6. She shall bring the following documents in **<u>original</u>** for reporting/ joining in the district:

- a. Three recent Passport size photographs
- b. Proof of identity from Aadhar Card/Voter ID/Passport/DL
- c. Admit Card issued by the Odisha Staff Selection Commission, Bhubaneswar.

- d. Educational Qualification, Graduate Course Certificate and other qualifications above graduation from the respective authorities
- e. Caste Certificate as applicable as per original category issued by competent authority
- f. Medical Certificate obtained from a Govt. Medical Officer as per *Annexure- B*.
- g. NCC B/C Certificate from the respective authority.
- h. Formal Relieving Order of acceptance of resignation from service issued by previous employer of any Government/ PSU/ State PSU/ Govt. funded autonomous bodies etc., if the candidate was earlier employed in Government/ PSU/ State PSU/ Govt. funded autonomous bodies etc. Mere copy of the letter of resignation will not be accepted.

7. She is required to purchase police uniform and accoutrement, messing expenses etc and accordingly require an expenditure of approximately Rs. 20,000/-. She shall come prepared with that.

8. She will undergo Cadet Sub-Inspector's Course of Training for a period of one year at the designated Training Institute and such other training as decided from time to time.

9. Special DGP Training & Director BPSPA, Bhubaneswar will decide the Training Institute(s) where she will undertake the Basic Course of Training, depending on the number of Sub-Inspectors who finally report and considering the Training Slots available at different Training Institute(s) and accordingly issue joining instructions for deputation/ reporting of the CSIs for training in due course. The time spent in the district before training will be excluded from the duration of Basic Course of Training.

10. She is liable to be discharged at any stage of her training, if her progress in monthly or periodical assessment is found unsatisfactory or she otherwise renders herself unfit by her actions or if she is found unsuitable for Police Service without previous notice as per Rule 22(3) of *Odisha Police Service (Method of Recruitment and Conditions of Service of Sub-Inspectors) Order, 2021* notified vide Home Deptt. Notification No. 4888/D&A dt. 05.02.2021 read with Rule 668 of Odisha Police Manual Rule, 1940.

11. She should be fit to attend parade and physical lessons throughout the Training Period. Any report from a Doctor declaring her as unfit to undergo lessons for any length of time will make her liable for discharge from service.

12. During the period of Training, she will be under the disciplinary control of Director, BPSPA, Bhubaneswar who can discharge her from service for conditions mentioned in Para- 10 & 11 supra.

13. It is again reiterated that the appointment is purely provisional subject to verification of original documents and medical fitness for police training/service as mentioned in aforesaid paragraphs.
