OFFICE ORDER No. 672 /Pers. I Date: 29 04.2023

The case of S.I. Anil Kumar Parida (Sl.No. 192 of CSB-2019) of Malkangiri district was placed before the Central Selection Board 2019 held at State Police Hdqrs., Cuttack on 19.06.2019 for consideration of his promotion to the rank of Inspector of Police but the findings of the CSB regarding his promotion was kept in individual sealed cover due to pendency of Sundargarh district Proceeding No. 10/2019 & 13/2019. In the meantime, Sundargarh district Prog. No. 10/2019 has been disposed of by S.P., Sundargarh by exonerating him from all the charges vide Sundargarh district D.O.No.1094 dtd 17.05.2021 and Sundargarh dist. Prog. No. 13/2019 has also been disposed of by D.G. & I.G. of Police, Odisha vide order dtd 11.05.2022 with a minor punishment i.e. "Censure in S.B." which has been communicated vide Sundargarh district D.O.No.1076 dtd 24.05.2022. After disposal of both the proceedings, S.I. Anil Kumar Parida has submitted a representation on dtd 21.03.2023 for consideration of his retrospective promotion to the rank of Inspector of Police from the year 2019. The matter was examined and placed before DGP, as per orders of the DGP the sealed cover containing the findings of the CSB for the year 2019 in respect of S.I. Anil Kumar Parida of Malkangiri district was opened on 24.04.2023 and found that he has been selected by the CSB for the year 2019.


S.I. Anil Kumar Parida of Malkangiri district is allowed for promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex-SI Dhiresh Kumar Das (CSB Sl.No.193 of 2019) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No.626/Pers.I. dtd 26.06.2019. Accordingly, his seniority in the rank of Inspector of Police is fixed above Inspector Ex.S.I. Dhiresh Kumar Das.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade/post. His posting will be decided by the Police Establishment Board.


On such promotion, he is posted to Ganjam district pending approval by Police Establishment Board.

This issues with the approval of DGP.
