

OFFICE ORDER NO. 718 /Pers.-II **DATE:** 09.08.2024

The Central Selection Board for the year-2024 was held on 29.02.2024 for promotion of ASI (Communication) to the rank of S.I (Communication) in Signal Establishment. The case of ASI (Communication) Sanjay Kumar Jena-II of Signals Establishment (CSB Sl. No.4) was placed before the CSB on 29.02.2024 for consideration his promotion to the rank of S.I (Communication). The CSB after scrutinizing the service record of Sanjay Kumar Jena-II decided to keep his recommendation in a sealed cover in pursuance of Govt. of Odisha G.A. Department Office memorandum No.3928/Gen dtd.18.02.1994 and subsequent amendment to the provision in the above O.M. vide G.A. Deptt. O.M. No.29699/Gen, dtd. 01.11.1997 as Jeypore Mahila P.S Case No. 62/2022 was pending against him.

After being acquitted vide order dtd. 29.02.2024 of the Hon'ble Court of the Session Judge-cum-Special Judge, Jeypore in Jeypore Mahila P.S Case No. 62/2022, Shri Sanjay Kumar Jena-II, ASI (Communication) submitted a representation dtd.11.03.2024 for consideration of his promotion to the rank of SI(Communication).

As per orders of the DGP the sealed cover containing findings of the CSB-2024 held on 29.02.2024 in respect of ASI (Communication) Sanjay Kumar Jena-II of Signals Establishment was opened on 26.06.2024 and found that he has been selected by the CSB for the year-2024 held on 29.02.2024 for promotion to the rank of SI (Communication).


Having been selected by the CSB,2024 held on 29.02.2024, ASI (Communication) Sanjay Kumar Jena-II of Signal Establishment is allowed retrospective promotion to the rank of S.I. (Communication) w.e.f. the date his immediate junior ASI (Communication) Alok Pradhan (now S.I. (Communication) (C.S.B.-No.5) was promoted to the rank of SI (Communication) as per the results of the CSB held on 29.02.2024. His promotion is subject to the result of W.P (C) No.1505/2020 filed by Shri Basudev Sahu and 9 other ASIs (Communication) as per interim Order No.3, dtd. 16.01.2020 passed by the Hon'ble High Court, Orissa in I.A. No. 603/2020 arising out of W.P(C) No. 1505/2020.

The inter-se-seniority of ASI (Communication) Sanjay Kumar Jena-II is fixed in the rank of SI (Communication) above Shri Alok Pradhan who was allowed promotion to the rank of SI (Communication) vide S.P. Hdqrs. Office Order No.271/Pers.-II dtd.14.03.2024.

His pay in the rank of SI (Communication) shall be fixed notionally from the date his immediate junior Alok Pradhan was promoted to the rank of SI (Communication). His promotional posting will be decided by the Range Police Establishment Board of Signal Establishment.
