Following constables of different districts (Parent Cadre) are absorbed in Districts as mentioned against each on consideration of their applications as per the terms and conditions laid down under Police Circular Order No. 342/2013.

As per the undertaking submitted by them, they will lose their seniority of parent cadre and their seniority in the Districts they are absorbed will be counted from the dates of their absorption in new cadre. Qualifying service required for promotion to the rank of Lance Naik, Havildar and ASI of Police will be counted from the dates of their absorption in districts they are absorbed. Any test they would have passed in previous (Parent) Districts will not be counted for their promotion to the rank of Lance Naik, Havildar, ASI of Police.
