It is a pleasure to welcome you as a Cadet Sergeant of Police at **Biju Patnaik State Police Academy (BPSPA), Bhubaneswar** on **07.05.2019**. You are requested to follow the joining instructions given below.

**Location of the Academy**

The Biju Patnaik State Police academy at Ranasinghpur is situated at a distance of 6 Kms from Baramunda Bus Stand in the State Capital of Odisha, Bhubaneswar towards Khurda on the southern side of N.H.5 and 01 Km. from Aiginia crossing before AIIMS Hospital. The Academy is situated at a distance of 12 Kms from Bhubaneswar Railway Station. Means of conveyance is available from the Bus Stand and Railway Station to the Academy.

**Reporting**

Please report at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar on **07.05.2019** AM positively for basic Sergeant's course of training. After reporting, your physical and medical fitness shall be checked by the Medical Officer, who will issue Medical fitness Certificate before acceptance of joining.

Approved uniform will be supplied on joining at BPSPA. However, please bring the following items alongwith you.

**FOR MALE CANDIDATES.**

1. Two pairs of formal trousers.
2. Full shirt, half shirt (formal).
3. Full shoes (formal) with socks.
4. Sports shoes (white) & white socks.
5. Tie.

**FOR WOMEN CANDIDATES.**

1. Formal Sarees/ Salwar Kameez.(formal)
2. Sports shoes (white) & white socks.

A box not exceeding the size of 3' X 2' X 1 ½ , Mosquito net/ blanket, bed holder etc. may also be brought for personal use.

Two pairs of P.T. Uniform (white T. Shirt and Track lower) will be made available at the Training Centre, on payment. Approximate cost may be of Rs.2,000/- (two thousand) only.

**Books and reading materials:**

Study materials and Law Books will be supplied on payment to the trainees on arrival at the Biju Patnaik State Police Academy (BPSPA), Bhubaneswar. The cost of the study materials may come approximately to Rs.3000/- (Three thousand) only.

**Deposit of Advances at the time of reporting:**

Each trainee shall have to deposit Rs.15,000/- (Rupees Fifteen thousand) only approximately in total towards (cost of Books-Rs.3000/-, Messing advance- Rs.8,000/-, P.T. Uniform – Rs.2,000/-, Miscellaneous-Rs.2000/-) with the Cashier of Biju Patnaik State Police Academy (BPSPA), Bhubaneswar.

**Laundry:**

The laundry has been outsourced to a reputed firm for machine washing and steam ironing. The charges are Rs.200/- per month for washing 40 garments.

**Medical Fitness Certificate.**

On arrival, the trainee shall appear before the Medical Officer (M.O) of Biju Patnaik State Police Academy (BPSPA), Bhubaneswar and get themselves medically examined. The M.O will issue a certificate indicating the fitness to undergo the physical training.

**Leave:** During the period of training, no leave will ordinarily be granted to the trainees, except in urgency.

Please submit the supporting original documents in respect of your age, Caste/ category, educational qualifications, Ex. Serviceman certificate, Sports certificate issued by the competent authority to the Biju Patnaik State Police Academy (BPSPA), Bhubaneswar for re-verification.
